- \$2 per week** Assists food banks in purchasing 12 meals for individuals and families experiencing financial difficulties.
- \$5 per week** Provides a victim of domestic violence six nights of safety and shelter.
- \$10 per week** Provides 35 at-risk teens with job training and placement to help prepare them for a successful future.
- \$20 per week** Provides a full year of professionally supported mentoring to youth in our community, assisting them in becoming confident, competent and caring adults.
- \$30 per week** Provides one low-income family with a pool fence to keep their children safe.
- \$50 per week** Helps 9 families access free financial services to increase their financial stability and move out of poverty.
